The undersigned, a member in good standing of Roller Skating Association International, Inc. ("RSA"), ("Member") hereby applies to participate in the music license between American Society of Composers, Authors and Publishers ("ASCAP") and RSA dated _____, between ASCAP and RSA (the "Agreement").

Member represents that it is a member in good standing of RSA and that it does not have any outstanding obligation to ASCAP. **Fees due for any location under an existing ASCAP Agreement must be paid in full, except for skate rental, to qualify for inclusion in the RSA Agreement.** The person signing this Authorization and Agreement shall be the contact person for Member with whom ASCAP and RSA may communicate as necessary regarding this Authorization and Agreement. Member agrees to notify ASCAP and RSA in writing of any change in the contact person, telephone number or address. Member further agrees that this Authorization and Agreement shall become part of the Agreement.

Member agrees that ASCAP shall have the right to verify all data or information regarding any Licensed Premises as may be necessary in order for ASCAP to verify license fees due from Member in any manner and records or other documents of Member which set forth the information needed to compute the license fee. Such information shall be made available to ASCAP by Member or RSA upon ASCAP's request.
